NOTICE OF RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS NOTICE OF RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release"), effective as of February 8, 2013, is made by Wells Fargo Bank, National Association (successor by merger to Wells Fargo Trade Capital, LLC), as collateral agent (in such capacity, the "Successor Collateral Agent"), in favor of Michael Kors, L.L.C., a Delaware limited liability company (the "Grantor").

WHEREAS, pursuant to that certain Notice of Grant of Security Interest in Trademarks, dated as of March 31, 2004 (the "2004 Security Agreement"), by Grantor and The CIT Group/Commercial Services, Inc., as collateral agent (in such capacity, the "Initial Agent"), recorded in the United States Patent and Trademark Office at Reel 2944, Frame 0847 and Reel 2944, Frame 0811 and pursuant to that certain Notice of Grant of Security Interest in Trademarks, dated as of August 30, 2007 (the "2007 Security Agreement"), by the Grantor and the Initial Agent, recorded in the United States Patent and Trademark Office at Reel 03628, Frame 0040, the Grantor assigned and granted to the Initial Agent a security interest in Grantor's right, title and interest in and to all of Grantor's trademarks (the "Trademarks"), including those listed on Exhibit A hereto, together with the goodwill of the business symbolized by the Trademarks, the applications, registrations and records related to the Trademarks and all proceeds thereof, including any and all causes of action which may exist by reason of infringement thereof (the "Released Assets");

WHEREAS, pursuant to that certain Notice of Grant of Security Interest in United States Trademarks, dated as of September 15, 2011, by the Grantor and the Successor Collateral Agent, recorded in the United States Patent and Trademark Office at Reel 4623, Frame 0464, the Grantor assigned and granted to the Successor Collateral Agent a security interest in Grantor's right, title and interest in and to the Released Assets;

WHEREAS, pursuant to that certain Notice of Substitution of Collateral Agent in Trademarks, dated as of September 15, 2011 (together with the 2004 Security Agreement and the 2007 Security Agreement, the "Security Agreement") by the Initial Agent, the Successor Collateral Agent, the Grantor and Michael Kors (USA), Inc., recorded in the United States Patent and Trademark Office at Reel 4623, Frame 0493, the Initial Agent assigned its entire security interest in the Released Assets to the Successor Collateral Agent; and

WHEREAS, the Successor Collateral Agent wishes to provide a document suitable for recording in the United States Patent and Trademark Office for purposes of recording the release, relinquishment and discharge of its security interest in the Released Assets;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Successor Collateral Agent agrees as follows:

1. Release. The Successor Collateral Agent hereby relinquishes, releases and discharges its security interest in the Released Assets and all right, title and interest of the Grantor in the Released Assets are hereby reassigned by the Successor Collateral Agent to the Grantor.

2. Further Assurances. The Successor Collateral Agent hereby authorizes the Grantor or the Grantor's authorized representative to record this Release with the United States

Patent and Trademark Office. The Successor Collateral Agent further agrees to execute and deliver to the Grantor any and all further documents and instruments, and do any and all further acts which the Grantor (or their agents or designees) reasonably request (at the Grantor's sole cost and expense) in order to confirm this Release and the Grantor's right, title and interest in, to and under the Released Assets.


3. Governing Law. This Release shall be governed by and construed and interpreted in accordance with the laws of the State of New York.

4. Definitions. Capitalized terms used herein and not defined shall have the respective meaning ascribed to such terms in the Security Agreement.




