TRADEMARK ASSIGNMENT

30<sup>th</sup> THIS TRADEMARK ASSIGNMENT (the "Assignment") is made and effective as of the day of January, 2013, by and between BOSS MANUFACTURING COMPANY, a Delaware corporation ("Assignor") and DAS BRANDS, LLC, a Pennsylvania limited liability company ("Assignee").

1. Assignment. Assignor hereby sells, assigns, transfers and conveys to Assignee all of its rights, title and interest in and to the Trademark, together with the goodwill of the business symbolized thereby, the same to be held and enjoyed by Assignee, its successors, assigns and legal representatives.
2. Cooperation. Assignor agrees to execute, acknowledge and deliver, or cause to be executed, acknowledged and delivered, such further instruments and documents and to perform such further acts as may be reasonably requested by Assignee to effectuate more fully the transactions contemplated by this Assignment.
3. Binding Effect. The terms, covenants and provisions of this Assignment shall inure to the benefit of Assignee, its successors, assigns and other legal representatives and shall be binding upon Assignor, its successors, assigns and other legal representatives.
