## RELEASE OF SECURITY INTEREST IN TRADEMARKS

RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated February 1, 2013 (the "Release") by Bank of America, N.A., a national bank, located at One Bryant Park, New York, NY 10036, in its capacity as successor collateral agent to Deutsche Bank Trust Company Americas pursuant to the Security Agreement (as defined below) (in such capacity, the "Collateral Agent"), in favor of XETA TECHNOLOGIES, INC., an Oklahoma corporation ("Xeta"), Quagga Corporation, a California corporation ("Quagga"), PAETEC COMMUNICATIONS, INC., a Delaware corporation ("Paetec"), PAETEC ITEL, L.L.C., a North Carolina limited liability company ("PaeTec iTel"), PAETEC SOFTWARE CORP., a New York corporation ("Paetec Software"), ALLWORX CORP., a Delaware corporation ("Allworx"), MCLEODUSA LLC, a Delaware corporation (as successor to MCLEODUSA INCORPORATED and MCLEODUSA HOLDINGS, INC.) ("McLeod"), and US LEC LLC (successor in interest to US LEC CORP.), a Delaware corporation ("US LEC", and together with Xeta, Quagga, Paetec, PaeTec iTel, Paetec Software, Allworx, and McLeod, the "Pledgors" and each, a "Pledgor"). Unless otherwise defined herein, terms defined in the Trademark Security Agreements (as defined below) and used herein have the meaning given to them in the Trademark Security Agreements.

### W I T N E S S E T H:

WHEREAS, the Pledgors and the Collateral Agent are party to that certain Amended and Restated Security Agreement, dated as of June 29, 2009 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement");

WHEREAS, Quagga is party to an Assignment of Security Interests in Trademarks, dated May 31, 2011, Xeta is party to a Grant of Security Interest in United States Trademarks, dated June 3, 2011, Paetec Software is party to a Grant of Security Interest in United States Trademarks, dated June 29, 2011, and each of the other Pledgors is party to a Grant of Security Interest in United States Trademarks, each of which is dated June 29, 2009, in each case, together with the Collateral Agent (collectively, the "Trademark Security Agreements");

WHEREAS, the Trademark Security Agreements were recorded with the United States Patent and Trademark Office ("USPTO") on June 15, 2011 at Reel/Frame 4564/0320 and 4563/0167, on July 22, 2011 at Reel/Frame 4602/0483, and on June 30, 2009, at Reel/Frame 4564/0320, Reel/Frame 4013/0578, Reel/Frame 4013/0600, Reel/Frame 4013/0616, Reel/Frame 4014/0400, Reel/Frame 4014/0407, and Reel/Frame 4018/0759, respectively;

WHEREAS, pursuant to the Security Agreement and the Trademark Security Agreements, as security for the payment in full of all the Obligations (as defined in the Security Agreement), each Pledgor granted to the Collateral Agent, a security interest in (i) all of such Pledgor's rights, title and interest in and to the United States trademarks

and all trademark applications (the “Trademarks”) set forth on Schedule A hereto, in each case together with (ii) all Proceeds (as defined in the Security Agreement) and products of the Trademarks, (iii) the goodwill of the business with which the Trademarks are associated, and (iv) all causes of action arising prior to or after the date hereof for infringement of any of the Trademarks or unfair competition regarding the same (collectively, the “Trademark Collateral”).

NOW, THEREFORE, in consideration of the premises and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Pledgors and the Collateral Agent hereby agree as follows:

SECTION 1. Release of Security Interest in the Trademark Collateral. The Collateral Agent hereby terminates and releases any and all of its security interest in all of its right, title and interest in, to and under the Trademark Collateral including, but not limited to, the Trademarks listed on Schedule A hereto.

SECTION 2. Recordation. The Collateral Agent hereby authorizes and requests that the Commissioner of Patents and Trademarks of the USPTO record this Release.

SECTION 3. Counterparts. This Release may be executed in any number of counterparts, all of which shall constitute one and the same instrument, and any party hereto may execute this Release by signing and delivering one or more counterparts.
