The undersigned officer of Jupiterimages Corporation, a corporation duly organized and existing under and by virtue of the Arizona Revised Statutes and the undersigned officer of Getty Images (US), Inc., a corporation duly organized and existing under and by virtue of the Business Corporation Law of the State of New York, do hereby certify as follows:

**FIRST:** (a) The name of each constituent corporation is as follows:

Jupiterimages Corporation, an Arizona corporation

Getty Images (US), Inc., a New York corporation

(b) The name of the surviving corporation is Getty Images (US), Inc. (the "Surviving Corporation"). The Surviving Corporation was originally incorporated in New York under the name Fried Kanney Associates Ltd.

(c) The name of the disappearing corporation is Jupiterimages Corporation. The disappearing corporation was originally incorporated in Arizona under the name ArtToday Merger Co., Inc. Jupiterimages Corporation filed an application for authority in New York on June 16, 2006.

**SECOND:** The designation and number of outstanding shares of each class of shares entitled to vote of each corporation to be merged, which shares are not subject to change prior to the Effective Date (as hereinafter defined) of the merger, are as follows:

**SIXTH:** Jupiterimages Corporation, an Arizona corporation, has complied with the applicable provisions of the laws of the State of Arizona in which it is incorporated, and this merger is permitted by such laws. The manner in which the merger was authorized with respect to said corporation was by the written consent of the holder of more than fifty percent (50%) of the issued and outstanding common stock.

**SEVENTH:** The effective date of the merger shall be the date of filing of this Certificate of Merger with the Department of State of the State of New York (the "*Effective Date*").
