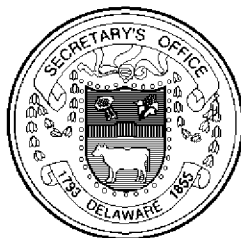

Akamai Technologies, Inc., a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware (the "Corporation"), does hereby certify:

**FIRST:** That the Corporation was incorporated on the 20<sup>th</sup> day of August, 1998, pursuant to the General Corporation Law of the State of Delaware.

foregoing, as they or any of them may deem appropriate to effect such merger.

RESOLVED: That the merger of Acerno Holdings, Inc. into the Corporation shall be effective as of 5:02 p.m. Eastern Standard Time on December 31, 2008.
