**ASSIGNMENT OF UNITED STATES
INTELLECTUAL PROPERTY RIGHTS**

WHEREAS, ASSIGNEE desires to acquire all rights, title and interest in and to the U.S. Intellectual Property and the U.S. Trademarks and all business goodwill associated therewith;


NOW, THEREFORE, TO ALL WHOM IT MAY CONCERN:
