RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT (this “Release”) is made as of February 15, 2013 (the “Effective Date”) by Barclays Bank PLC, as collateral agent for the Secured Parties (in such capacity, together with its successors and permitted assigns, the “Collateral Agent”), under that certain Trademark Security Agreement, between Ocwen Financial Corporation and Litton Loan Servicing LP, as grantors (the “Grantors”), and the Collateral Agent, dated as of September 1, 2011, as amended (the “Security Agreement”).

WHEREAS, pursuant to the terms and conditions of the Security Agreement, each Grantor pledged, assigned and granted to the Collateral Agent a continuing security interest in all of its right, title and interest in and to the Trademark Collateral (as defined in the Security Agreement hereinafter, the “Trademark Collateral”), including, without limitation, the trademark registrations, trademark applications and/or trademark licenses set forth on Schedule I hereto (collectively, with the goodwill associated therewith the “Trademarks”); and

WHEREAS, the Security Agreement relating to the Trademarks was recorded with the Assignment Division of the United States Patent and Trademark Office at Reel/Frame No. 4618/0605 on September 7, 2011.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby terminates the Security Agreement, and hereby terminates, cancels, re-pledges, reassigns and releases any and all security interests it has against the Trademark Collateral, including, without limitation the Trademarks, without warranty or recourse.


If and to the extent the Collateral Agent has acquired any right, title or interest to any of the Trademark Collateral, including, without limitation the Trademarks, it hereby assigns and transfers such rights, title or interest to the applicable Grantor.

The Collateral Agent shall, at the Grantors’ expense, take all further actions, and provide to the Grantors and each of their respective successors, assigns or other legal representatives, all such co-operation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantors to fully and effectively effectuate the purposes of this Release.
