### RECITALS

Assignor is the owner of and has adopted and used in the United States "Efloors Outlet," a service mark registered with the United States Patent & Trademark Office as No. 4086325 (the Mark");

Effective January 1, 2013 Assignor assigned all of Assignor's right, title and interest in the United States in and to the Mark, together with the goodwill of the business in connection with which the Mark is used;

Effective January 1, 2013 Assignee commenced use of the Mark in commerce and continued such use up and to this date; and

Assignor and Assignee desire to commemorate and document this Assignment on this 1<sup>st</sup> day of January 2013.


**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. Assignor does hereby sell, grant, assign, transfer, convey and deliver to Assignee all of its right, title and interest in the United States in and to the Mark together with the goodwill of the business in connection with which the Mark is used.
2. Assignor authorizes and requests the United States Patent and Trademark Office to record Assignee as the owner of the entire right, title and interest in and to the Mark in the United States, for the sole use and enjoyment of Assignee, its successors, assigns or other legal representatives.
3. At the request of Assignee, Assignor shall perform whatever acts are deemed necessary or desirable by Assignee to preserve and protect, and to vest in Assignee, ownership of and title to the Mark, including the execution and delivery of documents deemed necessary or desirable by Assignee.

**IN WITNESS WHEREOF**, Assignor and Assignee have caused this assignment to be signed and executed by their duly authorized officers or agents on the date first written above.


