**RELEASE OF SECURITY INTEREST**

This **RELEASE OF SECURITY INTEREST** (this "Release") is made as of February 6, 2013 ("Effective Date") by Square 1 Bank, a North Carolina bank (the "Bank"), in favor of Utopy, Inc., a Delaware corporation ("Grantor").

**WHEREAS**, reference is made to that certain Intellectual Property Security Agreement dated as of November 10, 2005 (as amended, restated, supplemented, or otherwise modified from time to time, the "Security Agreement"), by and among the Bank and Grantor;

**WHEREAS**, pursuant to the terms and conditions of the Security Agreement, Grantor granted to the Bank a security interest in all of Grantor's right, title and interest in and to the Intellectual Property Collateral (as such term is defined in the Security Agreement);


**WHEREAS**, the Security Agreement was recorded with the United States Patent and Trademark Office on January 9, 2006, at Reel 3223, Frame 0446; and

**WHEREAS**, Grantor has requested that the Bank release and reassign its security interest in the Intellectual Property Collateral, including, without limitation, the trademarks listed on Schedule 1 hereto.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Bank hereby terminates and releases in its entirety its security interest in and lien on the Intellectual Property Collateral. The Bank hereby authorizes and requests that the Commissioner for Trademarks and any other applicable government officer record this Release.

**IN WITNESS WHEREOF**, the Bank has caused this Release to be executed by its duly authorized representative as of the Effective Date.
