WHEREAS, the assumed name ComPsych has expired and the Company no longer conducts business under these assumed name but conducts business in the name of the Company; and



ComPsych hereby sells, transfers, assigns, conveys and delivers to the Company all of its right, title and interest in and to the Trademarks, together with the goodwill associated with any of the Trademarks, and all applications, registrations, renewals and extensions for any of the Trademarks, and all rights, claims and privileges pertaining to any of the Trademarks, including, without limitation, the right to prosecute and maintain trademark and service mark registrations and applications for any of the Trademarks and the right to sue and recover damages for past, present and future infringement of any of the Trademarks.
