MASTER ASSIGNMENT OF INTELLECTUAL PROPERTY

TO: BHP Billiton Diamonds (Belgium) N.V., of Hoveniersstraat 30, Bus 263-268, 2018 Antwerpen, Belgium ("Assignee")

FROM: Point Lake Marketing Inc., of Suite 800, Four Bentall Centre, 1055 Dunsmuir Street, PO Box 49223, Vancouver, British Columbia, V7X 1L2 ("Assignor")

In consideration of \$10.00, now paid by Assignee to Assignor, and other valuable consideration, the receipt and sufficiency of which Assignor hereby acknowledges:

3. Definitions – In this Instrument:

1.1 "Affiliate Agreement" means an agreement entered into by one or more related companies of the Assignor under which the Assignor is granted a beneficial interest in and to any and all Intellectual Property created, applied for, registered and/or managed by a party to the Affiliate Agreement in trust for and on behalf of the Assignor, including without limiting the generality of the foregoing, the Umbrella Services Agreement made between BHP Group Operations Pty Ltd (ABN 73 004 165 075) and BHP Innovation Pty Ltd (ABN 41 008 457 154) dated 1 February 2001 covering Assignor as a member of the BHP Group therein defined.

1.2 "AURIAS Program" means the program, methods, technologies, and tools developed and operated by or on behalf of Assignor to identify, certify and market Canadian Diamonds that meet the specifications needed to qualify for inclusion in the program.

1.3 "CANADAMARK Program" means the program, methods, technologies, and tools developed and operated by or on behalf of Assignor to track, manage, and market Canadian Diamonds as CANADAMARK diamonds.

1.4 "Intellectual Property" means all proprietary rights and interests throughout the world in, to, or associated with each of the CANADAMARK Program and AURIAS Program and related projects (collectively, the "Programs") that are owned or exclusively controlled by or licensed to Assignor, including, without limitation:

- (a) all trade-marks associated with the Programs ("Trade-Marks"), all issued registrations for the Trade-Marks, and all pending applications to register the Trade-Marks, including, without limitation, the registrations and applications identified in Schedule "A";
- (b) all trade dress and get-up of goods used by Assignor in connection with the Programs including, without limitation, the appearance of the CANADAMARK Certificate of Origin and the AURIAS Certificate of Origin;

- (c) all business names used by Assignor in connection with the Programs ("Business Names"), including, without limitation, "Point Lake Marketing Inc.", "Point Lake Marketing", and "Point Lake";
- (d) all domain names held or used by Assignor, or by others on behalf of Assignor that consist of or include any of the Trade-Marks including, without limitation, those identified in Schedule "B";
- (e) all copyrights, if any, in the Trade-Marks and in any computer programs, data, graphic designs, and written materials, authored or compiled by or for Assignor and used by Assignor in connection with the Programs;
- (f) all inventions (whether or not patentable), if any, invented by or for Assignor and used by Assignor in connection with the Programs ("Inventions");
- (g) all confidential information and trade secrets created, compiled or acquired by or for Assignor and used by Assignor in connection with the Programs ("Confidential Information"), including without limitation, Inventions, know-how, data, technology, techniques, business methods, and information about customer and licensees;
- (h) all goodwill appurtenant to the foregoing items or to the business in which those items are used;
- (i) the right to enforce any of the foregoing items against third parties, including the right to bring legal proceedings against others who infringe, misuse or otherwise violate any of the foregoing.

2. **Assignment** – Assignor hereby sells, assigns, and transfers to Assignee effective 29 June 2007 all Assignor's right, title and interest throughout the world, in, to, and associated with the Intellectual Property, for Assignee's own benefit.

3. **Acceptance** – Assignee hereby accepts the sale, transfer and assignment granted under Section 2 above.

4. **Intellectual Property Owned by Related Companies** – Assignee hereby acknowledges and accepts that certain specific units of Intellectual Property may be registered in the name(s) of one or more companies with which Assignor is affiliated ("Affiliate-Owned Intellectual Property") and that, in certain cases, the Affiliate-Owned Intellectual Property is held by the affiliated company in trust for Assignor, and/or is used by Assignor under license from the affiliated company, and/or is subject to an Affiliate Agreement. Accordingly, Assignor's grants and covenants set out in this Instrument will apply to Affiliate-Owned Intellectual Property only to the following extent:

- (a) the grant set out in Section 2 above will only transfer whatever interest Assignor may have in Affiliate-Owned Intellectual Property, if any, to the extent permitted by law and any applicable Affiliate Agreement;

- (b) if requested, Assignor will provide reasonable assistance to Assignee to arrange for transfer to Assignee of full ownership of Affiliate-Owned Intellectual Property; and
- (c) if the legal owner of any Affiliate-Owned Intellectual Property refuses to, or is incapable of, transferring any Affiliate-Owned Intellectual Property to Assignee, then, Assignor will provide reasonable assistance to Assignee to arrange for transfer to Assignee of Assignor's interest under any applicable Affiliate Agreement.

Assignor will not have any additional obligation or liability in respect of Affiliate-Owned Intellectual Property.

5. Additional Instruments – This Instrument is fully effective to transfer all of the Intellectual Property to Assignee. However, Assignor and Assignee will each sign and file any additional documents that may be reasonably requested by the other to register or record the transfer of particular items of Intellectual Property, including assignments and powers of attorney for specific marks and jurisdictions.

6. Confidentiality – When of this Instrument becomes effective, Assignor will hold the Confidential Information in confidence and will not disclose it to any third party without the express written authorization of Assignee.

7. Right of Retraction – Regardless of anything else in this Instrument, Assignor will have the right to require Assignee to:

- (a) transfer back to Assignor any Trade-Marks and Business Names that consist of or include the words POINT LAKE (“POINT LAKE Marks and Names”), together with all appurtenant goodwill;
- (b) grant to Assignor a license to use POINT LAKE Marks and Names with whatever scope of license is requested by Assignor (but subject to any rights of third parties previously granted by Assignee);
- (c) cease all use of POINT LAKE Marks and Names and abandon and cancel all applications and registrations for POINT LAKE Marks and Names;

by giving Assignee written notice of Assignor's election to require such steps. Assignee will promptly comply with any such requests.

8. Power of Attorney – Assignor hereby irrevocably nominates, appoints, and constitutes the Managing Director of Assignee, Gordon Carlyle, as its true and lawful attorney, with power, coupled with an interest, to do all things and execute and deliver all documents on its behalf as may be required to effect, register, record, or otherwise perfect the sale, transfer, and assignment set out herein, and to execute any instruments required for that purpose, with power of substitution and delegation.

9. Termination of Prior License Agreement – The Parties hereby agree to terminate the trade-mark license agreement between them dated 20 December, 2005, and to take



all steps required to register and record the fact that all Domain Names in the .eu TLD using such trade-marks as a component thereof are now owned and used by Assignee entirely for its own benefit and not under license or as a mere trustee.

10. **Successors and Assigns** – Assignee may assign or license any or all of its rights under this Instrument, provided that any party who receives an assignment of this Instrument expressly agrees to assume all Assignee’s obligations under this Instrument. All parties to whom Assignee assigns or licenses any of those rights will receive the full benefit of all Assignor’s covenants and grants set out in this Instrument. This Instrument will bind Assignor, Assignee, and their respective heirs, successors, permitted assigns, and legal representatives.



