RELEASE OF SECURITY INTEREST

This RELEASE OF SECURITY INTEREST (this "*Release*") is executed by LONE STAR BANK, S.S.B. f.k.a. First State Bank, Moulton, Texas, a Texas corporation ("*Pledgee*"), to evidence the release and discharge of the liens and security interests described below.

WHEREAS, EARL CAMPBELL FOODS, INC., a Delaware corporation (the "*Pledgor*"), entered into two Tradename Pledge Agreements dated December 2, 1999, and March 22, 2000 (collectively, the "*Tradename Pledge Agreements*"), with Pledgee, whereby the Pledgor granted to the Pledgee a security interest in and to all right, title and interest of the Pledgor in, to and under the trade names and trademarks listed on the attached *Schedule A*, which trademarks are registered in the United States Patent and Trademark Office (all of the trade names and trademarks individually and/or collectively referred to as the "*Trademarks*"), together with, among other things, the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present and future violations thereof, to secure the prompt and full payment and complete performance of the Obligations (as defined in the Tradename Pledge Agreements) of Pledgor;

WHEREAS, pursuant to that certain Trademark Assignment Agreement dated as of May 31, 2001, the Pledgor assigned all of the Pledgor's right, title, and interest in, to, and under the Trademarks to Earl Campbell Meat Products, Inc., a Nevada corporation ("*Earl Campbell Meat Products*"), and as of the date hereof, Earl Campbell Meat Products is the owner of the Trademarks;

WHEREAS, executed copies of the Tradename Pledge Agreements were recorded in the United States Patent and Trademark Office as follows:

WHEREAS, the Pledgor has satisfied and fulfilled all of its obligations to release Pledgee's security interest in the Trademarks under the Tradename Pledge Agreements, and the parties seek to make a record of the Pledgee's release of any and all of Pledgee's security interests in the Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Pledgee hereby:

1. Releases, discharges, and relinquishes any and all liens, security interests, right, title and interest of Pledgee pursuant to the Tradename Pledge Agreements in the Trademarks, and any liens, security interest, right, title and interest in the Trademarks in favor of the Pledgee's successors and assigns are hereby released, discharged, and relinquished. The Pledgee specifically acknowledges that its security interests in the Trademarks are no longer in force;

2. Agrees that any power of attorney or similar rights with respect to enforcing the Trademarks granted by Pledgor to Pledgee pursuant to or in connection with the Tradename Pledge Agreements is terminated; and

3. Authorizes and requests that the Patent and Trademark Office note and record the existence of the release hereby given.

This Release shall be governed by, and construed in accordance with, the laws of the United States applicable to trade name and trademarks and to trade name and trademarks rights and the laws of the State of Texas applicable to contracts executed in or to be performed in the State of Texas.

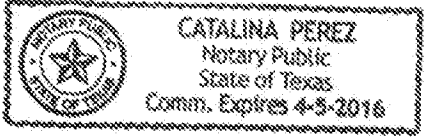
