ASSIGNMENT

2. FURTHER ASSURANCES

Bell Helicopter Rhode Island and Bell Helicopter hereby further agree, each for itself and its successors, assigns, and legal representatives, to execute upon request any other lawful documents and likewise to perform any other lawful acts that are necessary and useful to secure fully the aforesaid rights, titles, and interests in and to said trademarks listed in Exhibit A to Bell Helicopter, its successors, assigns, legal representatives.
