TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS dated as of February 28, 2013, from General Electric Capital Corporation, a Delaware corporation (“GE Capital”), in its capacity as administrative agent (in such capacity, together with its successors and permitted assigns, the “Agent”) for the Lenders and the L/C Issuers (as defined in the Second Amended and Restated Credit Agreement, dated as of September 21, 2010 (as the same may be amended, restated, supplemented, or otherwise modified from time to time, the “Credit Agreement”) and the other Secured Parties, in favor the entities listed on the signature pages hereof (each, a “Grantor” and, collectively, the “Grantors”).

WITNESSETH:

WHEREAS, pursuant to the Credit Agreement, Grantor and the Agent entered into that certain Second Amended and Restated Guaranty and Security Agreement, dated as of September 21, 2010, by and between Grantor, the Agent and the other parties thereto (as the same may be amended, restated, supplemented or otherwise modified from time to time, the “Guaranty and Security Agreement”);

WHEREAS, pursuant to the Guaranty and Security Agreement, Grantor entered into that certain Amended and Restated Trademark Security Agreement dated as of September 21, 2010 (the “First Trademark Security Agreement”) and the Trademark Security Agreement dated as of October 13, 2011 (the “Second Trademark Security Agreement”), in favor of the Agent, under which Grantor granted to the Agent a Lien on and security interest in all of such Grantor's right, title and interest in, to and under certain intellectual property, including the items set forth of Exhibit I, and the other Trademark Collateral (as defined in the First Trademark Security Agreement and the Second Trademark Security Agreement);

WHEREAS, the First Trademark Security Agreement was recorded with the Assignment Division of the United States Patent and Trademark Office (“USPTO”) on Reel 4283, Frame 0930;

WHEREAS, the Second Trademark Security Agreement was recorded with the Assignment Division of the USPTO on Reel 4643, Frame 0621; and

WHEREAS, each Grantor has paid all of its outstanding indebtedness to the Agent, and the Agent now desires to terminate and release the entirety of any and all security interest it may have in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademark Collateral pursuant to the First Trademark Security Agreement and the Second Trademark Security Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, Agent hereby states as follows:

1. Definitions. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Credit Agreement, the First Trademark Security Agreement and the Second Trademark Security Agreement.

2. Release of Security Interest. Agent hereby (i) terminates, cancels, releases, and discharges any and all security interest it may have in the Trademark Collateral, including, without limitation, the trademarks listed in Exhibit I attached hereto, (ii) terminates the First Trademark Security Agreement and the Second Trademark Security Agreement and (iii) re-assigns to each Grantor any right, title and interest it may have in, to and under the Trademark Collateral. Any and all right, title, or interest of Agent in, to, and under such Trademark Collateral and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement of the Trademark Collateral, shall hereby cease and become void.


3. Further Assurances. Agent hereby agrees to duly execute, acknowledge, procure, and deliver any further documents and to do any such other acts and provide to Grantor, its successors, assigns or other legal representatives all such cooperation and assistance, as may be reasonably requested by each Grantor to more fully and effectively effect the release of any and all security interest it may have in the Trademark Collateral contemplated hereby.

4. Governing Law. This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS shall be governed by and construed in accordance with the laws of the State of New York.
