TRADEMARK ASSIGNMENT

(INTENT TO USE TRADEMARK APPLICATIONS)

This Trademark Assignment (this "Assignment") is made January 18, 2013 by Continental Industries, Inc., an Oklahoma corporation ("Assignor") to Burndy LLC, a Delaware limited liability company ("Assignee").

WHEREAS, on December 14, 2012, Assignor, Assignee, Hubbell Incorporated, a Connecticut corporation, and Handy & Harman Group, Ltd., a Delaware corporation, entered into an Asset Purchase Agreement (the "Purchase Agreement"), pursuant to which Assignor agreed to assign to Burndy substantially all of the assets of the Business (as defined in the Purchase Agreement), and as a result, Assignee is the successor to the Business;

WHEREAS, Assignor owns and has had the intent to use the trademarks set forth in Schedule A (the "Marks"), and has agreed to assign to Assignee or its designee all of Assignor's title, rights and interest in and to the Marks, as part of its sale to Assignee of the Business; and

WHEREAS, Assignor and Assignee wish to document the formal assignment to Assignee of all of Assignor's title, interest and rights in and to the Marks and the goodwill associated therewith.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby sell, assign, transfer and set over to Assignee all of Assignor's right, title, and interest in and to the Marks, together with all translations, adaptations, derivations, and combinations thereof and including all goodwill associated therewith, and all applications, registrations, and renewals in connection therewith, and all other rights accruing thereunder or pertaining thereto throughout the world, including the right to sue and otherwise recover for all past, present, and future infringement, dilution or other violations thereof, for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment had not been made.


Assignor authorizes the Commissioner for Patents and Trademarks and any other governmental officials to record and register this Assignment upon request by Assignee.


