RELEASE OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, **DURHAM GEO-ENTERPRISES, INC.** a Georgia corporation with offices located at 2175 West Park Court, Stone Mountain Georgia 30087 ("**Grantor**"), granted a security interest in and lien upon certain trademarks and related rights to **PNC BANK, NATIONAL ASSOCIATION**, a national banking association, as successor in interest to **RBC BANK (USA)**, a North Carolina banking corporation ("**Grantee**"), as set forth in a certain Intellectual Property Security Agreement dated as of September 14, 2009 by and among Grantor and Grantee (as amended, modified or supplemented, the "**Security Agreement**");

1. releases and reassigns to Grantor, without recourse, any and all liens, security interests, right, title and interest of Grantee pursuant to the Security Agreement in the trademarks more fully identified in Schedule A, without recourse or representation or warranty, express or implied, of any kind;
2. agrees that any power of attorney or similar rights granted by Grantor to Grantee pursuant to or in connection with the Security Agreement is terminated; and
3. authorizes and requests that the United States Patent and Trademark Office note and record the existence of the release hereby given.
