RELEASE OF TRADEMARK ASSIGNMENT AND SECURITY INTEREST

FOR VALUE RECEIVED, the undersigned, WELLS FARGO BANK, NATIONAL ASSOCIATION, as Administrative Agent (the "Secured Party"), does hereby grant, assign and convey absolutely, and release any security interest in or collateral assignment of, the Trademark Collateral (as defined below), granted and pledged to it by ARBOR PHARMACEUTICALS, INC., a Delaware corporation (the "Grantor"), pursuant to that certain Grant of Security Interest in Trademarks, dated as of November 21, 2011, between Secured Party and Grantor (the "Security Agreement"), and reassigns the Trademark Collateral to Grantor. The Secured Party represents and warrants that: (i) it has the full power and authority to execute this Release of Trademark Assignment and Security Interest; and (ii) it has not assigned, transferred, restricted or otherwise encumbered its rights under the Security Agreement.

The Secured Party shall, at Grantor's sole cost and expense, take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantor to more fully and effectively effectuate the purposes of this release.
