**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARK COLLATERAL**

This RELEASE, dated as of February 28, 2013 is made by ROYAL BANK OF CANADA, in its capacity as administrative agent and collateral agent for the Lenders (the "Agent").

W I T N E S S E T H

WHEREAS, pursuant to that certain Guarantee and Collateral Agreement dated as of November 9, 2012, made by Milk Specialties Company (the "Grantor") and certain of its affiliates in favor of the Agent, a security interest ("Security Interest") was granted by the Grantor to the Agent in certain collateral, including the Trademark Collateral (as herein defined);

WHEREAS, a Security Interest in the Trademark Collateral was recorded in the United States Patent and Trademark Office on November 13, 2012 at Reel 4898, Frame 0831; and

WHEREAS, the Agent now desires to terminate and release the entirety of the Security Interest in the Trademark Collateral listed on Schedule I hereto.

NOW, THEREFORE, for good and valuable consideration, and upon the terms set forth in this Release, the Agent hereby states as follows:

1. Definitions. The term "Trademark Collateral," as used herein, shall mean all of the Grantor's right, title, and interest of every kind and nature as of the date hereof in the Trademarks listed on Schedule I hereto. The term "Trademarks" shall have the meaning provided to such term in the Guarantee and Collateral Agreement.
2. Release of Security Interest. The Agent hereby terminates, releases, and discharges, without representation, warranty or recourse of any kind, its Security Interest in the Trademark Collateral.
3. Filing of the Release; Further Assurances. The Agent hereby authorizes the filing of this Release in the United States Patent and Trademark Office by the Grantor (or the Grantor's designee) at the request and sole expense of the Grantor, and agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.
