**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARK COLLATERAL**

This RELEASE, dated as of February 5, 2013 is made by JEFFERIES FINANCE LLC, in its capacity as Agent for the Lenders (the "Agent").

W I T N E S S E T H

WHEREAS, pursuant to the First Lien Guarantee and Collateral Agreement dated November 30, 2011, made by Healogics, Inc. (f/k/a National Healing Corporation) and its Affiliates (the "Grantors") in favor of the Agent, a security interest ("Security Interest") was granted by the Grantors to the Agent in certain collateral, including the Trademark Collateral (as herein defined);

WHEREAS, a Security Interest in the Trademark Collateral was recorded in the United States Patent & Trademark Office on December 02, 2011 at Reel 4671, Frame 0447; and

WHEREAS, the Agent now desires to terminate and release the entirety of the Security Interest in the Trademark Collateral, including without limitation those items listed on Schedule I hereto.


NOW, THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademark Collateral pursuant to the Amended and Restated Guarantee and Collateral Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Release, the Agent hereby states as follows:

1. Definitions. The term "Trademark Collateral," as used herein, shall mean all of the Grantor's right, title, and interest of every kind and nature as of the date hereof in the Trademarks (including, without limitation those items listed on Schedule I hereto). The term "Trademarks" shall have the meaning provided by reference to the Amended and Restated Guarantee and Collateral Agreement.
2. Release of Security Interest. The Agent hereby terminates, releases, and discharges its Security Interest in the Trademark Collateral, and any right title and interest of the Agent in such Trademark Collateral shall hereby cease and become void.
3. Filing of the Release; Further Assurances. The Agent hereby authorizes the filing of this Release in the United States Patent & Trademark Office by the Grantors (or the Grantors' designee) at the request and sole expense of the Grantors, and agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.
