RELEASE OF TRADEMARK COLLATERAL ASSIGNMENT AND SECURITY AGREEMENT

This Release of Trademark Collateral Assignment and Security Agreement, dated as of January 9, 2013, is by and between Fast Fare LLC, a Maryland limited liability company, successor by merger to Fast Fare, Inc. ("Fast Fare") and Wells Fargo Bank, National Association, successor in interest to Wachovia Bank, National Association, successor by merger to Congress Financial Corporation, as Agent ("Secured Party").

WHEREAS, the parties entered into a Trademark Collateral Assignment and Security Agreement dated January 25, 2005 ("Trademark Security Agreement"), in which Fast Fare granted a security interest in the registered trademarks, trade names, terms, designs, and applications therefor described in Exhibit A hereto and made a part hereof; and

WHEREAS, the Loan Agreement and other Financing Agreements (as those terms are defined in the Trademark Security Agreement) that were secured in part by the Trademark Security Agreement have now been fully paid, discharged, and satisfied.

NOW THEREFORE, in consideration of the premises and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Secured Party hereby agrees as follows:

1. That the Trademark Security Agreement is terminated and of no further force and effect.
2. To release the Security Agreement submission filed with the U.S. Patent and Trademark Office (USPTO) on or about March 31, 2005 at Reel 003140, Frame 0622 or as otherwise indexed by the USPTO.
3. To authorize Fast Fare to make, at Fast Fare's expense, whatever filings are necessary with the USPTO to release all of Secured Party's security interests on the trademarks identified in Exhibit A.
4. To reasonably cooperate with Fast Fare in obtaining the release of the March 31, 2005 USPTO Security Agreement filing.
