TRADEMARK ASSIGNMENT

Each Assignor hereby sells, assigns, transfers and sets over to Assignee, its successors and assigns, all right, title, and interest in and to the Marks together with the goodwill of the business in connection with which the Marks have been used, and rights to sue or make claims for any past, present or future infringement, misappropriation or unauthorized use of any the foregoing, and the rights to all damages, royalties or other payments that are now due or may become due and payable with respect to any of the foregoing.

Assignors hereby request the United States Patent and Trademark Office Commissioner for Trademarks and any other applicable governmental entity or registrar (including any applicable foreign or international office or registrar), to record Assignee as the assignee and owner of the Marks. Assignors hereby authorize and request the officials of all countries in which any of the Marks is now or will in the future be issued to issue to Assignee all of each Assignor's right, title and interest in and to the same, for the sole use and enjoyment of Assignee.

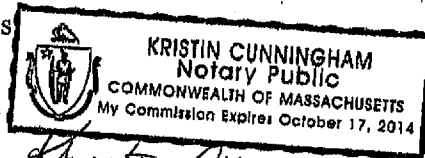

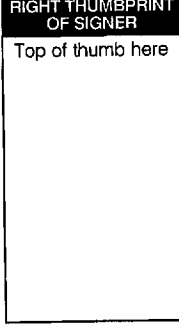


