**ASSIGNMENT OF

WHEREAS, William A.B. NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR hereby assigns, transfers and sells, unto ASSIGNEE, its legal representatives and assigns, all of ASSIGNOR'S worldwide right, title, interest, associated goodwill, and all rights of action against third parties ASSIGNOR has or may have in the future in and to said Mark, including, without limitation, all trademark and service mark rights, trade dress rights and any and all other intellectual property rights in the Mark, together with the Registrations and any other applications or registrations for the Mark, effective as of the Effective Date; which interests and rights shall be held and enjoyed by ASSIGNEE as fully and entirely as the same would have been held by ASSIGNOR had this transfer, assignment, and sale not been made.

IN WITNESS WHEREOF, the undersigned, intending to be legally bound, has caused this Assignment of Intellectual Property rights to be executed effective as of the 4th day of April, 2007 (the "Effective Date").
