**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN TRADEMARK RIGHTS**

TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS (this "Termination and Release") dated as of March 4, 2013, from Suntrust Bank, a Georgia banking corporation with an address at 303 Peachtree Street, N.E., 25<sup>th</sup> Floor, Atlanta, Georgia 30308, as administrative agent on behalf of the lenders, (the "Agent"), to Associated Asphalt, Inc. (the "Obligor").

WITNESSETH:

WHEREAS, pursuant to a Trademark Security Agreement dated as of October 26, 2006 between the Agent and the Obligor (the "Trademark Security Agreement"), a security interest (the "Security Interest") was granted by the Obligor to the Agent in the Trademark Collateral (as hereinafter defined);

WHEREAS, the Trademark Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on October 26, 2006 at Reel 3416 Frame 0842; and


WHEREAS, the Agent now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Agent hereby states as follows:

1. Definitions. The term "Trademark Collateral" shall include all of Obligor's right, title and interest of every kind and nature as of the date hereof in, to and under the trademark applications and registrations listed on Schedule A hereto.
2. Release of Security Interest. The Agent hereby terminates, releases and discharges its Security Interest in the Trademark Collateral, and any right, title or interest of the Agent in, to or under the Trademark Collateral shall hereby cease and become void.
3. Further Assurances. The Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect, evidence and/or record the release of the Security Interest contemplated hereby.
