ASSIGNMENT

(with goodwill)

THIS ASSIGNMENT is made the 1st day of March 2013

BETWEEN:

Mr. Christian RESTOIN, a French citizen living 38 bis, rue Fabert 75007 Paris, France ("the Assignor")

AND

RBR, LLC, a US company duly organized and existing under the laws of the State of California, having its head office and principal place of business at 4599 District Boulevard, Vernon, California 90058 USA ("the Assignee")

BACKGROUND :-

- A. The Assignor is the owner of the trade mark Reg. No. 1.672.663 for EQUIPMENT BY CHRISTIAN RESTOIN in class 25 (hereafter collectively "Trade Mark").
- B. The Assignor has agreed with the Assignee to assign the Trade Mark to the Assignee upon the terms and conditions set out in this assignment.

IT IS HEREBY AGREED as follows: -

- 1. For good and valuable consideration now paid by the Assignee to the Assignor, the receipt of which is hereby acknowledged, the Assignor ASSIGNS to the Assignee to hold to the Assignee absolutely all of Assignor's entire right, title and interest in and to the Trade Mark together with the whole of the goodwill of the business connected with the goods for which the Trade Mark is registered and/or used, and including all right to sue and collect damages for any past infringement of the Trade Mark.
- 2. The Assignor shall at the request and expense of the Assignee execute and do all acts and things as may be necessary or proper to confirm and record the assignment of the rights referred to in clause 1 and the proprietorship of the Assignee therein.

3. Pending recordal of the Assignee as the registered proprietor and owner of the Trade Mark on the relevant Trade Mark Registers, the Assignor agrees to lend its name to any proceedings for infringement of the Trade Mark, and the Assignee agrees to indemnify the Assignor for all costs and other liabilities incurred by the Assignor arising directly out of such proceedings.
4. The Assignor covenants with the Assignee that it has not done or knowingly suffered or been party or privy to any act or thing whereby it is prevented from validly assigning the rights referred to in clause 1.
5. In this Assignment the expressions "Assignor" and "Assignee" shall, where the context so admits, include their respective successors, heirs and assigns.
