TERMINATION AND RELEASE OF ASSIGNMENT OF SECURITY INTEREST IN TRADEMARKS

THIS TERMINATION AND RELEASE OF ASSIGNMENT OF SECURITY INTEREST IN TRADEMARKS (this "Termination"), is dated as of November 30, 2012 and made by **The Prudential Insurance Company of America**, as collateral agent (the "Collateral Agent") to **Aavid Thermalloy, LLC**, a Delaware limited liability company ("Aavid LLC"), **Aavid Thermal Technologies, Inc.**, a Delaware corporation ("Aavid Thermal"), **Aavid Thermally Limited**, an England and Wales limited company ("Aavid Limited") and **Aavid Corporation** (f/k/a Aavid Thermal Products, Inc. and Thermalloy, Inc.), a Delaware corporation ("Aavid Corp" and together with Aavid LLC, Aavid Thermal and Aavid Limited, collectively, the "Assignors").

WHEREAS, pursuant to that certain Assignment of Security Interests in Trademarks dated as of December 22, 2010, made by the Assignors (other than Aavid Limited) in favor of the Collateral Agent (the "Trademark Security Assignment"), a security interest and lien was granted by the Assignors (other than Aavid Limited) to the Agent in certain collateral, including the Trademarks (as hereinafter defined);

WHEREAS, the Trademark Security Assignment was recorded with the United States Patent and Trademark Office on January 13, 2011, at Reel 004452 and Frame 0092; and

WHEREAS, the Collateral Agent now desires to terminate and release the Trademark Security Assignment.


NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, the Collateral Agent hereby states as follows.

1. Definitions. The term "Trademarks," as used herein, shall mean all of the Assignors' right, title and interest of every kind and nature in, to and under all trademarks and service marks and all registrations and applications for registration therefor (together with the goodwill associated therewith and including all proceeds thereof (e.g., license royalties and proceeds of infringement suits), the right to sue for past, present and future infringements, all rights corresponding thereto throughout the world and all extensions and renewals thereof) that Collateral Agent was granted a security interest in and a continuing lien upon pursuant to the Trademark Security Assignment, including in the trademark registrations and applications listed on Schedule A hereto.

2. Release of Security Interest. The Collateral Agent hereby (i) terminates the Trademark Security Assignment, (ii) terminates, releases and discharges its security interest in and lien upon the Trademarks and (iii) with respect to each Trademark, reassigns all of Collateral Agent's right, title and interest in such Trademark to the applicable Assignor as set forth on Schedule A hereto (or, if such Trademark is not set forth on Schedule A, to the Assignor (or its successor or assign) that owned such right, title or interest as of the date of the Trademark Security Agreement).




