**ARTICLES OF AMENDMENT TO THE
RESTATED ARTICLES OF INCORPORATION OF
INFOTECH DEVELOPMENT CORPORATION**

Pursuant to the provisions of the Utah Revised Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Restated Articles of Incorporation with Amendments:

FIRST: The name of the corporation is Infotech Development Corporation.

SECOND: The Restated Articles of Incorporation are amended hereby by revising Article FIRST to read as follows in its entirety:

FIRST: The name of the Corporation is CHARTLOGIC, INC.

THIRD: The manner in which any exchange, reclassification, or cancellation of issued shares provided for in the amendment shall be effected is as follows: None.

FOURTH: The foregoing amendment to the Restated Articles of Incorporation was adopted by a vote of the Board of Directors on January 20, 2003, and on March 31, 2003, by unanimous written consent of the holders of 20,740,000 shares of Common Stock, which shares constitute all of the issued and outstanding Common Stock on March 31, 2003, and by unanimous written consent of the holders of 13,645,318 shares of Series A Preferred Stock, which shares constitute all of the issued and outstanding Preferred Stock on March 31, 2003, in accordance with Sections 16-10a-704 and 16-10a-1006 of the Utah Revised Business Corporation Act. No other voting group exists or was entitled to vote separately on the amendment.
