RELEASE OF SECURITY INTEREST IN UNITED STATES TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN UNITED STATES TRADEMARKS (“Release”) is made effective as of March 6, 2013 (“Effective Date”), by JPMorgan Chase Bank, N.A., for itself and as (i) administrative agent pursuant to the 2006 Security Agreement (as defined below) and (ii) collateral agent pursuant to the 2010 Security Agreement (as defined below) (collectively in such roles, the “Administrative Agent”) to and in favor of Sutherland Global Services Inc., (the “Grantor”), as follows:

WHEREAS, on December 14, 2006, Grantor, certain Subsidiaries of the Grantor and the Collateral Agent entered into a General Security Agreement (as further amended, restated, supplemented or otherwise modified from time to time, the “2006 Security Agreement”);

WHEREAS, on May 4, 2010, Grantor, certain Subsidiaries of the Grantor and the Administrative Agent entered into an Amended and Restated Pledge and Security Agreement (as further amended, restated, supplemented or otherwise modified from time to time, the “2010 Security Agreement”);

WHEREAS, pursuant to (i) the Trademark Security Agreement dated December 14, 2006 and recorded with the U.S. Patent and Trademark Office on December 20, 2006 at Reel/Frame No. 3450/0829 (the “Trademark Security Agreement”), and (ii) the Confirmatory Grant of Security Interest in United States Trademarks dated May 4, 2010 and recorded with the U.S. Patent and Trademark Office on May 4, 2010 at Reel/Frame No. 4198/0769 (collectively, the “Confirmatory Grant”), the Grantor granted to the Administrative Agent, a security interest in (1) all of the Grantor’s right, title and interest, in and to the Trademarks then owned or from time to time after the date thereof owned or acquired by Grantor including the United States Trademarks listed on the attached Schedule A, together with (2) all proceeds of such Trademarks, (3) the goodwill associated with such Trademarks and (4) all causes of action arising prior to or after the date thereof for infringement of such Trademarks or unfair competition regarding the same, (the “Trademark Collateral”); and

WHEREAS, Administrative Agent wishes to release its security interest in the Trademark Collateral.

NOW THEREFORE, as the Grantor has satisfied its obligations under said Security Agreement and Confirmatory Grant, the Administrative Agent hereby releases its security interest in the Trademark Collateral, and reassigns any and all interest the Administrative Agent may have in the Trademark Collateral to the Grantor.
