Under Section 805 of the Business Corporation Law

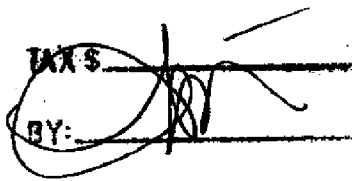

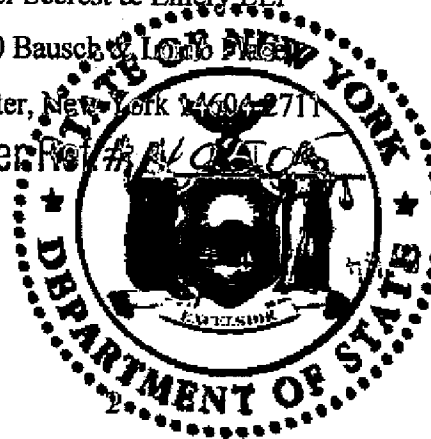
