**RELEASE OF SECURITY INTEREST IN UNITED STATES TRADEMARKS**

THIS RELEASE OF SECURITY INTEREST IN UNITED STATES TRADEMARKS (“Release”) is made effective as of March 6, 2013 (“Effective Date”), by JPMorgan Chase Bank, N.A., for itself and as Administrative Agent to the Secured Parties (the “Administrative Agent”) to and in favor of Sutherland Global Services Inc., (the “Grantor”), as follows:

WHEREAS, on May 4, 2010, Grantor, certain Subsidiaries of the Grantor and the Administrative Agent entered into an Amended and Restated Pledge and Security Agreement (as further amended, restated, supplemented or otherwise modified from time to time, the “Security Agreement”);

WHEREAS, on May 4, 2010, the Grantor executed in favor of the Administrative Agent a Confirmatory Grant of Security Interest in United States Trademarks (the “Confirmatory Grant”);

WHEREAS, pursuant to the Security Agreement and Confirmatory Grant, the Grantor granted to the Administrative Agent, a security interest in (1) all of the Grantor’s right, title and interest, in and to the Trademarks then owned or from time to time after the date thereof owned or acquired by Grantor including the United States Trademarks listed on the attached Schedule A, together with (2) all proceeds of such Trademarks, (3) the goodwill associated with such Trademarks and (4) all causes of action arising prior to or after the date thereof for infringement of such Trademarks or unfair competition regarding the same, (the “Trademark Collateral”); and

WHEREAS, the Confirmatory Grant was recorded in the United States Patent and Trademark Office (“USPTO”) on May 4, 2010, at reel/frame 4198/769; and

WHEREAS, Administrative Agent wishes to release its security interest in the the Trademark Collateral.

NOW THEREFORE, as the Grantor has satisfied its obligations under said Security Agreement and Confirmatory Grant, the Administrative Agent hereby releases its security interest in the Trademark Collateral, and reassigns any and all interest the Administrative Agent may have in the Trademark Collateral to the Grantor.
