- 2.1 The Assignor represents and warrants that it is the sole legal and beneficial owner of and owns all the rights and interests in the Trade Marks.

3 FURTHER ASSURANCE

- 3.1 The Assignor agrees to execute any further documents and to do all things which may be necessary to give effect to this assignment, including all things which may be necessary to enable the Assignee to record this assignment in the records of the relevant trade mark offices and registries.

4 GENERAL

- 4.1 This assignment may be signed in any number of counterparts, and this has the same effect as if the signatures on the counterparts were on a single copy of this assignment.

4.2 This assignment shall be governed by and construed in accordance with English law and the parties submit to the exclusive jurisdiction of the English courts for all purposes relating to this assignment.
