SUPPLEMENT NO. 3 TO TRADEMARK SECURITY AGREEMENT

February 14, 2013

BELKIN INTERNATIONAL, INC., a Delaware corporation ("Debtor") with offices located at 12045 East Waterfront Drive, Playa Vista, CA 90094, hereby acknowledges that it has granted to **WELLS FARGO CAPITAL FINANCE, LLC**, a Delaware limited liability company ("Secured Party") with offices located at 2450 Colorado Avenue, Suite 3000W, Santa Monica, CA 90404, a security interest in and to all of Debtor's right, title and interest in and to the trademarks and trademark registrations and applications therefor which are identified on Schedule I attached hereto and herein incorporated by this reference owned by Debtor (the "Trademarks"), together with the goodwill and assets of the business, as set forth in the Agreement (as such term is defined below).
