**TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK
COLLATERAL**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL** (this “Release”) is made as of February 28, 2013 (“Effective Date”) by Wells Fargo Capital Finance, LLC, a Delaware limited liability company (“WFCF”), in its capacity as agent for the Lender Group and the Bank Product Providers, as such terms are defined in the below defined Credit Agreement (together with its successors in such capacity, “Grantee”), in favor of the grantors listed on Schedule 1 hereto (each a “Grantor” and collectively, the “Grantors”).

WHEREAS, reference is made to that certain Credit Agreement dated as of November 23, 2011 (as amended, restated, supplemented, or otherwise modified from time to time, the “Credit Agreement”), by and among the lenders identified on the signature pages thereof, Grantee, **FIRST ADVANTAGE CORPORATION** (formerly known as STG-Fairway Holdings, Inc.), a Delaware corporation (“Parent”), and **STG-FAIRWAY ACQUISITIONS, INC.**, a Delaware corporation (“Borrower”);

WHEREAS, pursuant to the terms and conditions of that certain Trademark Security Agreement dated as of November 23, 2011 and recorded with the United States Patent and Trademark Office on November 23, 2011 at Reel 4665, Frame 0882, as amended by Amendment Number One to Trademark Security Agreement dated as of November 21, 2012 and recorded with the United States Patent and Trademark Office on November 21, 2012 at Reel 4905, Frame 0338, by and among the Grantors and Grantee (as amended, restated, supplemented, or otherwise modified and in effect from time to time, collectively the “Trademark Security Agreement”), the Grantors granted to Grantee a security interest in all of the Grantors’ right, title and interest in and to the Trademark Collateral (as such term is defined in the Trademark Security Agreement); and

WHEREAS, Grantee now desires to release its security interest in the Trademark Collateral, including, without limitation, the trademark registrations and applications listed on Schedule 2 hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby covenants and agrees as follows:

1. Without representation or warranty of any kind or nature, Grantee hereby terminates, releases, and discharges its security interest in the Trademark Collateral granted pursuant to the Trademark Security Agreement, and reassigns to the Grantors all right, title, and interest of Grantee in the Trademark Collateral pursuant to the Trademark Security Agreement.

2. Grantee hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts, in each case at the Grantors’ expense, as may be reasonably necessary to effect the release of the security interest in the Trademark Collateral contemplated hereby.
