NUNC PRO TUNC ASSIGNMENT OF TRADEMARK

WHEREAS, A. O. Smith Corporation, a Delaware corporation of 11270 W. Park Place, Milwaukee, WI 53224 ("Assignor") is the owner of U.S. Registration No. 3,916,492 for the mark 4-IN-1 (the "Mark");

WHEREAS, Assignor and Regal Beloit EPC Inc., a Wisconsin corporation of 200 State Street, Beloit, WI 53511 ("Assignee"), are parties to a certain Asset and Stock Purchase Agreement dated as of December 12, 2010 (the "Purchase Agreement"), pursuant to the terms of which Assignor agreed to assign to Assignee all of Assignor's right, title and interest in and to certain of the Assignor's intellectual property ("Purchased Intellectual Property");
