**TRADEMARK ASSIGNMENT**

WHEREAS, Jobson Medical Information LLC, a Delaware limited liability company (the "Assignor"), having a principal place of business at 100 Avenue of the Americas, 9<sup>th</sup> Floor, New York, NY 10013, has adopted, acquired, used and is using in a substantially exclusive and continuous manner in its business the trademark CENTERWATCH (the "Trademark") and owns U.S. Registrations Nos. 3,682,870 and 3,682,867 therefor (the "Registrations");

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor does hereby assign unto Assignee, its successors and assigns, all of its right, title and interest, whether statutory or at common law, in and to the Trademark and the Registrations, together with all the goodwill of the business symbolized by the Trademark in the United States and all countries throughout the world, and together with the right to sue and collect damages and/or profits for past infringements of the Trademark in Assignor's place.

Assignor further authorizes the Director of the U.S. Patent and Trademark Office to record this assignment and to identify the Registrations in its records as the property of Assignee, its successors, legal representatives and assigns. Assignor shall execute such further documents as may be reasonably required to record Assignee as the owner of the Trademark and the Registrations at Assignee's sole expense.

This Agreement may be executed in several counterparts, each of which shall be deemed an original, but all of which together will constitute one and the same instrument.
