ASSIGNMENT OF TRADEMARKS

WHEREAS, AARDEX GROUP LTD. and AARDEX LTD, corporations organized and existing under the laws of Switzerland, with a place of business at Ave De La Gare 29, 1950 Sion Switzerland (hereinafter referred to as "ASSIGNOR"), own the trademarks set forth on Schedule A hereto (the TRADEMARKS);

NOW THEREFORE, in consideration of the sum of One Dollar (\$1.00) and other good and valuable consideration, the sufficiency and receipt of which is hereby acknowledged:

ASSIGNOR hereby transfers to ASSIGNEE the entire right, title and interest of ASSIGNOR in and to the TRADEMARKS together with the goodwill of the business associated with the TRADEMARKS; and


ASSIGNOR, does hereby sell, assign, transfer and set over unto ASSIGNEE, its successors, legal representatives and assigns all claims for damages by reason of past infringements of the TRADEMARKS, the right to sue for and collect the same for its own use and enjoyment and for the use and enjoyment of its successors, assigns, or other legal representative;

ASSIGNOR further authorizes the Commissioner of Patents and Trademarks of the United States and other countries to record the TRADEMARKS as property of ASSIGNEE; and


ASSIGNOR further agrees to execute such further documents as may be required to record ASSIGNEE as the owner of the TRADEMARKS.
