TERMINATION AND RELEASE OF SECURITY INTEREST  
IN TRADEMARKS

TERMINATION AND RELEASE, dated as of December 1, 2009, from THE BANK OF NEW YORK MELLON, as Administrative Agent, to Salem Communications Holding Corporation (the "Borrower"), Salem Communications Corporation (the "Parent"), CCM Communications, Inc., Caron Broadcasting, Inc., Common Ground Broadcasting, Inc., New Inspiration Broadcasting Company, Inc., OnePlace, LLC, Salem Media of Illinois, LLC, and Salem Radio Network, Inc. (the "Subsidiary Pledgors"); and the Subsidiary Guarantors, together with the Borrower and the Parent, the "Pledgors").

WITNESSETH:

WHEREAS, The Bank of New York Mellon (formerly The Bank of New York) is the Administrative Agent (in such capacity, the "Administrative Agent") under the Fifth Amended and Restated Credit Agreement, dated as of September 25, 2003 (as amended, the "Credit Agreement"), among the Borrower, the Parent, the lenders party thereto and the Administrative Agent;

WHEREAS, in order to secure its obligations under the Fifth Amended and Restated Credit Agreement, the Pledgors entered into the Amended and Restated Security Agreement, dated as of September 25, 2003, among the Borrower, the Parent, the Subsidiary Guarantors (including the Subsidiary Pledgors) party thereto and the Administrative Agent (as amended, the "Security Agreement");

WHEREAS, pursuant to the Amended and Restated Security Agreement, a security interest (the "Security Interest") in certain Collateral (as hereinafter defined) was granted by the Pledgors to the Administrative Agent, which Security Interest was recorded in the Trademark Division of the United States Patent & Trademark Office (the "USPTO") at the reels and frames as set forth on Schedule A; and

WHEREAS, the Administrative Agent now desires to terminate and release the entirety of its Security Interest in the Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Administrative Agent hereby agrees as follows:

I. Collateral. The term "Collateral," as used herein, shall mean all of the Pledgor's right, title and interest of every kind and nature in and to the United States trademarks and service marks set forth on Schedule A attached hereto, which trademarks are filed and/or registered in the USPTO (the "Trademarks"), together with the goodwill of the business symbolized by the Trademarks and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof.

2. Release. The Administrative Agent hereby terminates and releases in its entirety the Security Interest in the Collateral.

3. Recordation. The Administrative Agent hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States to record this release of the Security Interest in the Collateral.

4. Further Assurance. The Administrative Agent hereby agrees, at the sole expense of the Pledgor, to execute, acknowledge, procure and deliver any further documents, including, but not limited to, those documents necessary under Article 9 of the Uniform Commercial Code or other applicable law, and to do such other acts as may be reasonably necessary to effect the release of the Security Interest in the Collateral contemplated hereby.

5. Modification. This Termination and Release may not be modified, nor may any provision hereof be waived, orally or in any manner other than by an agreement in writing signed by the parties hereto or their respective successors and assigns.


