WHEREAS, Warner Music Inc., a company incorporated under the laws of the State of Delaware, United States of America, with offices at 75 Rockefeller Plaza, New York, New York 10019 ("Assignee"), desires to acquire all of the right, title and interest of Assignor in, to and under the Trademarks, together with the goodwill of the business symbolized by the Trademarks;



NOW, THEREFORE, in consideration of the execution of the Asset Purchase Agreement, the payment of the consideration stipulated in the Asset Purchase Agreement and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby transfers, conveys and assigns to Assignee all right, title and interest throughout the world in and to the Trademarks, together with (a) all national, foreign and state registrations, applications for registration and renewals and extensions thereof; (b) all common law rights related thereto; (c) all goodwill of the business symbolized by the Trademarks, and (d) all benefits, privileges, causes of action and remedies relating to any of the foregoing, whether before or hereafter accrued (including, without limitation, the exclusive rights to apply for and maintain all such registrations, renewals and extensions; to sue for all past, present or future infringements or other violations of any rights in the Trademarks; and to settle and retain proceeds from any such actions).

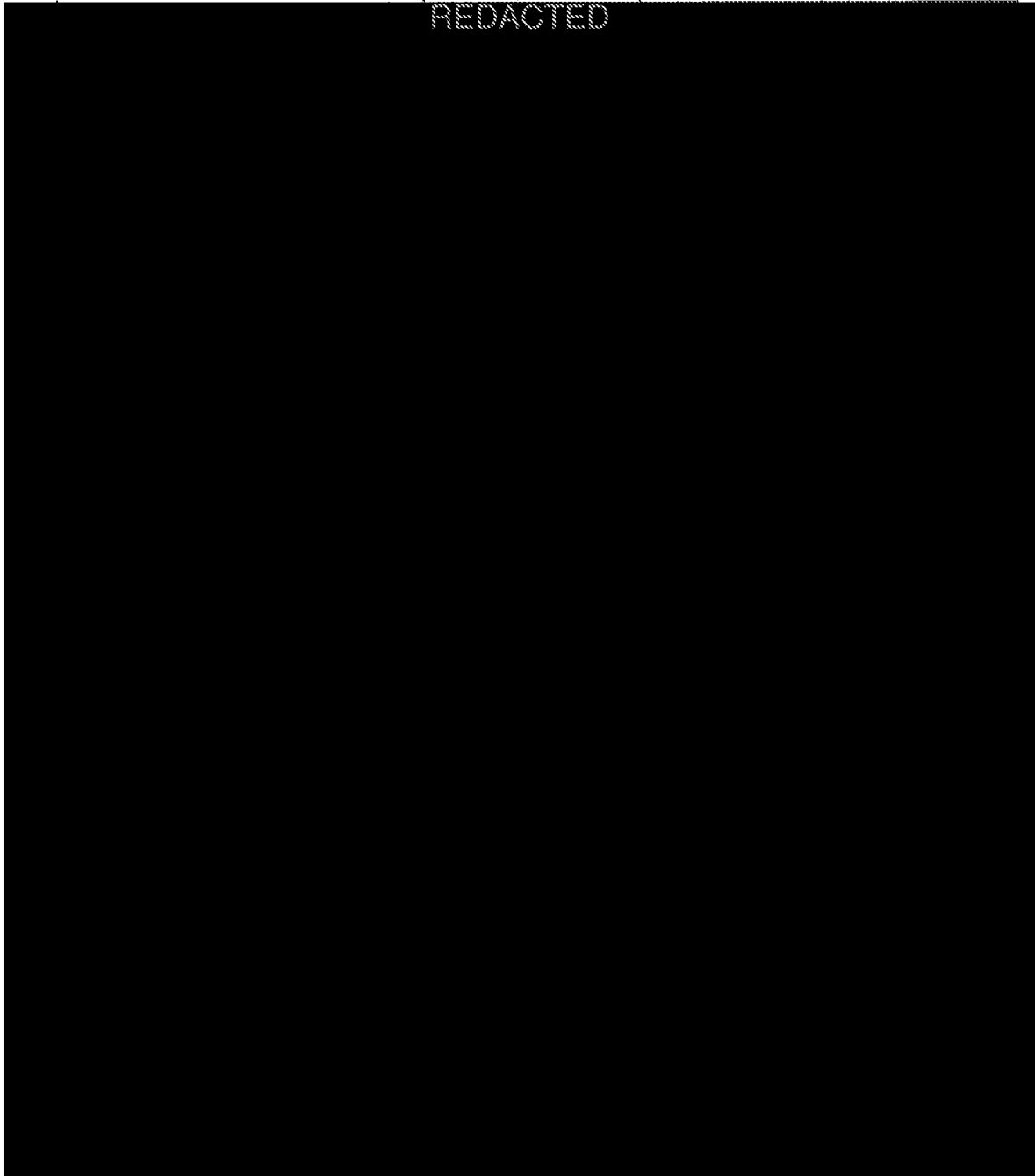
