RELEASE OF SECURITY INTEREST
IN TRADEMARK

SAINTSBURY LLC, a California limited liability company, f/k/a VIVETTE & COMPANY, a California limited partnership, doing business as Saintsbury ("Saintsbury") with an address at 1500 Los Carneros Avenue, Napa, California 94559, granted a security interest in a certain trademark in favor of Union Bank of California, N.A., a national banking association ("Union Bank").
