AGREEMENT REGARDING TRADEMARK ASSIGNMENT

THIS AGREEMENT is between CESARI S.R.L., a limited liability company of Italy with a principal place of business at Via Stanzano N. 1120, 40024 Castel S. Pietro Terme, Bologna, Italy ("Assignor") and CASA VINICOLA SARTORI S.P.A., a corporation of Italy with a principal place of business at Via Casette N. 2, Negrar in Valpolicella, Verona, Italy ("Assignee").

The Assignor and Assignee agree as follows:

Assignor was the owner of the trademark REFOLO of US trademark registration No. 2,967,476 (the "Trademark");

On January 24, 2013, for good and valuable consideration, Assignor assigned, transferred, and conveyed to Assignee, its successors and assigns forever, Assignor's entire right, title and interest in, to the Trademark, and the goodwill of the business symbolized thereby and in and to any corresponding foreign trademark rights in the mark REFOLO. The assignment included all statutory and/or common law rights and/or foreign trademark rights for such Trademark, and any and all rights to contest, protest or sue at law or in equity for any infringement, imitation, impairment, distortion, dilution or other unauthorized use or conduct in derogation of the Trademark, including the right to receive all proceeds and damages therefrom. The assignment included all rights to obtain registrations and/or renewals of registration or other legal protections pertaining to the Trademark; and

This Agreement may be recorded in the US Patent and Trademark Office and shall have the same force and effect as if the original assignment was recorded.


