## ASSIGNMENT OF TRADEMARK RIGHTS

This Assignment of Trademark Rights (the "**Agreement**") is made effective as of June 28, 2011 (the "**Effective Date**"), by and between YogaGlo, LLC, a California limited liability company ("**Assignor**"), and YogaGlo, Inc., a Delaware corporation ("**Assignee**").

WHEREAS, Assignor is the owner of the trademarks, service marks and/or trade names and all applications therefor (collectively, "**Trademarks**") specified in Schedule A attached hereto;

WHEREAS, Assignee desires to acquire the entire and exclusive right, title and interest and any associated goodwill in and to the Trademarks; and

WHEREAS, Assignor is willing to assign to Assignee all rights, title and interest and any associated goodwill in and to the Trademarks.

NOW, THEREFORE, for good and valuable consideration, the sufficiency of which is hereby acknowledged, Assignor hereby assigns to Assignee all right, title and interest in and to the Trademarks, together with the goodwill of the business symbolized by the Trademarks, and the applications or registrations therefor as identified in Schedule A. This assignment includes the right to sue and recover damages for past and future infringements of Assignor's rights in the Trademarks and to bring any proceeding in the United States Patent and Trademark Office or any equivalent agency in any other country for cancellation or opposition or other proceeding in connection with the Trademarks. The right, title and interest is to be held and enjoyed by Assignee and Assignee's successors and assigns as fully and exclusively as it would have been held and enjoyed by Assignor had this assignment not been made.

Assignor further agrees that it will execute, verify, acknowledge and deliver all such further papers, including any instruments of transfer and recordable assignments, and perform such other acts as Assignee lawfully may request from time to time, to perfect and vest title in the Trademarks in Assignee, or Assignee's successors and assigns.

This Agreement shall be governed by and enforced in accordance with the laws of the State of California, without giving effect to any conflicts of law principles.


This Agreement shall be binding on, and shall inure to the benefit of, the parties hereto and their respective successors and assigns.

IN WITNESS WHEREOF, the parties hereto have caused this Agreement to be executed by their respective duly authorized officers, as of the Effective Date.


