Assignor hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States, and any Official of any country or countries foreign to the United States, whose duty it is to issue trademarks, to issue the same to the said Assignee, its successors, legal representatives and assigns, in accordance with the terms of this instrument.

Assignor hereby covenants that it has full right to convey its entire interest herein assigned, and that it has not executed, and will not execute, any agreement in conflict herewith.

Assignor further covenants and agrees that it will communicate to the said Assignee, its successors, legal representatives and assigns, any facts known to Assignor respecting said mark, and testify in any legal proceeding, sign all lawful papers, execute all divisions, continuing and reissue applications, execute all renewals, make all rightful oaths and generally do everything possible to aid the said Assignee, its successors, legal representatives and assigns, to obtain and enforce proper trademark protection for said Trademarks in all countries.
