**GRANT OF SECURITY INTEREST
IN UNITED STATES TRADEMARKS**

March 20, 2013

FOR GOOD AND VALUABLE CONSIDERATION, the receipt and sufficiency of which are hereby acknowledged, MULTIBAND CORPORATION, a Minnesota corporation ("Multiband"), MULTIBAND FIELD SERVICES, INC., a Delaware corporation ("Multiband Field") and MULTIBAND SUBSCRIBER SERVICES, INC., a Minnesota corporation ("Multiband Subscriber" and together with Multiband and Multiband Field, each a "Grantor" and collectively, the "Grantors"), with offices at 5605 Green Circle Drive, Minnetonka, MN 55343, hereby grant to FIFTH THIRD BANK, an Ohio banking corporation (the "Secured Party") with offices at 222 South Riverside Plaza, 32nd Floor, Chicago, Illinois 60606, as Agent under the Guarantee and Collateral Agreement referred to below, a security interest in (i) all trademarks, trade names, corporate names, company names, business names, fictitious business names, trade styles, service marks, certification marks, collective marks, logos, other source of business identifiers, prints and labels on which any of the foregoing have appeared or appear, designs and general intangibles of a like nature (each of the foregoing, a "Trademark"), all registrations and all applications in connection therewith, whether pending or in preparation for filing, including all common law rights in the Trademark and registrations and applications in the United States Patent and Trademark Office or in any office or agency of the United States of America or any State thereof or any foreign country, including without limitation those listed on Schedule A hereto, (ii) all Trademark licenses; (iii) all reissues, extensions or renewals of any item described in clause (i) or (ii); (iv) all of the goodwill of the business connected with the use of, and symbolized by, any item described in clause (i) or (ii); and (v) all proceeds of, and rights associated with, the foregoing, including without limitation any claim by the Grantor against third parties for past, present or future infringement or dilution of any Trademark, Trademark registration or Trademark license, including without limitation any Trademark, Trademark registration or Trademark license referred to in Schedule A, or for any injury to the goodwill associated with the use of any Trademark or for breach or enforcement of any Trademark license.

THIS GRANT is made to secure the satisfactory performance and payment of all the Liabilities, as defined in the Credit Agreement, as such term is defined in the Guarantee and Collateral Agreement, dated as of the date hereof (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Guarantee and Collateral Agreement"), among the Grantors, the other parties to the Guarantee and Collateral Agreement as Grantors (as defined therein), and the Secured Party, as Agent (as defined in the Guarantee and Collateral Agreement).

This Grant is being made in conjunction with the security interest granted to the Secured Party under the Guarantee and Collateral Agreement. The rights and remedies of the Secured Party with respect to the security interest granted herein are without prejudice to, and are in addition to, those set forth in the Guarantee and Collateral Agreement, all relevant terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Grant are deemed to conflict with the Guarantee and Collateral Agreement, the provisions of the Guarantee and Collateral Agreement shall govern. The Grantors and the Secured Party hereby

acknowledge and agree that the security interest in the Trademarks (i) may only be terminated in accordance with the Guarantee and Collateral Agreement and (ii) is not to be construed as an assignment of any Trademark.




