

WHEREAS, Assignee wishes to acquire from the Assignor all right, title and interest in and to the Intellectual Property Assets.

Assignor assigns the Intellectual Property Assets as part of that portion of the business to which the Intellectual Property Assets pertains as may be required by the relevant statutes of each respective jurisdiction set forth in Schedule A.
