RELEASE AND TERMINATION OF SECURITY INTEREST

THIS RELEASE AND TERMINATION OF SECURITY INTEREST, dated as of February 22, 2013, is made by **STEEL CITY CAPITAL FUNDING, LLC**, as successor in interest to **PNC BANK, NATIONAL ASSOCIATION** ("STEEL CITY").

WHEREAS, **FOX RUN HOLDINGS, INC., FOX RUN USA, LLC, FOX RUN CANADA CORPORATION** and **SHANGHAI KITCHEN TOOL ACCESSORIES, LTD.** (the "Borrower") granted a security interest to STEEL CITY pursuant to that certain Loan and Security Agreement, dated August 18, 2006 (the "Loan Agreement"), and recorded in the records of the United States Trademark Office on September 11, 2006, at Reel 3386/Frame 0476 (the "Security Interest");

WHEREAS, the Security Interest secured certain obligations from the Borrower in favor of STEEL CITY (the "Obligations");

WHEREAS, the Borrower has satisfied and performed the Obligations in full; and

WHEREAS, STEEL CITY has agreed to terminate any security interest it has pursuant to the Loan Agreement and release the Security Interest in all of the property described herein, including, without limitation, the Trademarks identified on Schedule 1 attached hereto.

NOW, THEREFORE, for valuable consideration, STEEL CITY hereby terminates and releases the Security Interest and its lien, encumbrance and security interest, and requests the Commissioner of Patents and Trademarks of the United States of America to note and record the existence of the Release hereby given, in the following:

1. each trademark, trademark registration and trademark application of the Borrower, including, without limitation, the trademarks, trademark registrations and trademark applications referred to in Schedule 1 attached hereto and all of the goodwill symbolized thereby; and
2. each trademark license to which the Borrower is a party.

IN WITNESS WHEREOF, STEEL CITY has caused this Release and Termination of Security Interest to be duly executed as of the date first set forth above.


