## TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of March 22, 2013, by GENERAL ELECTRIC CAPITAL CORPORATION, a Delaware corporation, as administrative agent ("Agent") in favor of EPICOR INDUSTRIES, INC., a Delaware corporation, (the "Grantor"). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement (as defined below) or IP Security Agreement (as defined below) as applicable.

### WITNESSETH:

WHEREAS, Grantor and Agent are parties to that certain Guaranty and Security Agreement dated as of October 27, 2011 (as amended, restated, supplemented or otherwise modified from time to time, referred to as the "Security Agreement"), and that certain Trademark Security Agreement dated as of October 27, 2011 (as amended, restated, supplemented or otherwise modified from time to time, the "IP Security Agreement"), pursuant to which Grantor granted a security interest to Agent in the Trademark Collateral (as defined below) as security for certain obligations owing by Grantor to Agent, including the Trademarks set forth on Schedule 1 hereto; and

WHEREAS, the IP Security Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on October 27, 2011, at Reel 4649, Frame 0687; and

WHEREAS, Grantor has requested that Agent release its security interest in the Trademark Collateral and reassign the same to the Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby releases its Liens on and its security interest in all of Grantor's right, title and interest in and to the following (collectively the "Trademark Collateral"), including, without limitation:

(a) all of its Trademarks and all IP Licenses providing for the grant by or to such Grantor of any right under any Trademark, including, without limitation, those referred to on Schedule 1 hereto;

(b) all renewals and extensions of the foregoing;

(c) all goodwill of the business connected with the use of, and symbolized by, each such Trademark; and

(d) all income, royalties, proceeds and Liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including, without

limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof.

2. Agent hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Agent, all of Agent's right, title and interest in and to the Trademark Collateral.

3. Agent agrees, at the Grantor's sole expense, to reasonably cooperate with the Grantor to the extent necessary to further evidence the release of the Agent's security interest in and lien on the Trademark Collateral.

4. This agreement and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
