**NOTICE OF RELEASE OF
SECURITY INTEREST IN UNITED STATES TRADEMARKS
(PULITZER NEWSPAPERS, INC.)**

WHEREAS, by a Grant of Security Interest (Trademarks, Service Marks and Trade Names) dated as of January 30, 2012 (the "Trademark Security Agreement") and recorded in the United States Patent and Trademark Office on February 8, 2012, at Reel 4713, Frame 606, **PULITZER NEWSPAPERS, INC.**, a Delaware corporation ("Assignor") assigned to and granted to **THE BANK OF NEW YORK MELLON TRUST COMPANY, N.A.**, ("Collateral Agent"), a security interest in all right, title and interest of Assignor in and to the United States Trademarks listed on Exhibit A (the "Trademarks").

The Collateral Agent agrees, at the Assignor's expense, to cooperate with the Assignor, to execute, deliver and file any additional documents, and to provide the Assignor with the information and additional authorization reasonably required or desirable to effect the release, relinquishment or discharge of the Collateral Agent's security interest in the released collateral described herein.
