This is to certify that the following resolutions were adopted by the Board of Directors of People's Bank (now known as "People's United Bank") at a meeting held on April 19, 2007, which resolutions remain in effect:

WHEREAS, after consideration and discussion, the Board of Directors has determined that it is in the best interest of the Bank to amend the Bank's Charter and Bylaws to provide that the name of the Bank shall be "People's United Bank."

NOW, THEREFORE, IT IS RESOLVED, to amend Article I of the Bank's Charter as follows:

ARTICLE I
