RELEASE OF SECURITY INTEREST IN TRADEMARKS

If and to the extent the Releasor has acquired any right, title or interest in and to any of the Trademark Collateral pursuant to the terms of the Security Agreement, Releasor hereby reassigns and transfers such right, title and interest to Lien Grantor, without any representation, warranty or undertaking by, or recourse to, Releasor.
