**TERMINATION AND RELEASE OF SECOND LIEN SECURITY INTEREST  
IN TRADEMARK RIGHTS**

TERMINATION AND RELEASE dated as of March 22, 2013, from JPMorgan Chase Bank, N.A., as Collateral Agent (in such capacity, the "Agent") for certain banks and other financial institutions (the "Lenders"), to The Sun Products Corporation (f/k/a Huish Detergents, Inc.), a Delaware corporation (the "Obligor").

WITNESSETH:

WHEREAS, pursuant to the Second Lien Credit Agreement, dated as of April 26, 2007, by and among Obligor, Spotless Acquisition Corp. (together with Obligor, the "Borrowers"), Spotless Holding Corp., the Lenders, the Agent, J.P. Morgan Securities Inc. and Banc of America Securities LLC, as joint lead arrangers and as joint bookrunners, and Bank of America, N.A. as syndication agent (as amended, supplemented or otherwise modified from time to time, the "Second Lien Credit Agreement"), the Lenders severally agreed to make Loans and other extensions of credit to Borrowers upon the terms and subject to the conditions set forth therein;

WHEREAS, in connection with the Second Lien Credit Agreement, the Borrowers executed and delivered a Second Lien Guarantee and Security Agreement dated as of April 26, 2007, in favor of the Agent (together with all amendments and modifications, if any, from time to time thereafter made thereto, the "Second Lien Security Agreement"), Obligor granted a security interest (the "Security Interest") to the Agent in certain collateral, including the Trademark Collateral (as that term is defined in the Trademark Security Agreement (as hereinafter defined), including the Trademarks set forth on Schedule A hereto);

WHEREAS, pursuant to that certain Second Lien Grant of Security Interest in Trademark Rights dated as of September 8, 2008, between the Obligor and the Agent (the "Trademark Security Agreement"), Obligor, by reference to the Second Lien Credit Agreement and Second Lien Security Agreement, reaffirmed its intent to grant a Security Interest to the Agent specifically in certain Trademark Collateral;

WHEREAS, the Trademark Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on October 14, 2008, at Reel 003870 and Frame 0562; and

WHEREAS, the Agent now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Agent hereby states as follows:


1. Definitions. Capitalized terms not otherwise defined herein have the respective meanings ascribed thereto in the Second Lien Credit Agreement, the Second Lien Security Agreement, or the Trademark Security Agreement, as applicable.
2. Release of Security Interest. The Agent hereby terminates, releases and discharges, without representation, recourse or warranty whatsoever, its Security Interest in the Trademark Collateral, and any right, title or interest of the Agent in such Trademark Collateral shall hereby cease and become void and the Agent hereby reassigns any and all such right, title and interest (if any) that the Agent may have in the Trademark Collateral to the Obligor.
3. Further Assurances. The Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.
4. Counterparts. This Termination and Release may be executed in counterparts, each of which will be deemed an original, but all of which together constitute one and the same original.
