TRADEMARK RELEASE

THIS TRADEMARK RELEASE is made as of March 27, 2013, by GENERAL ELECTRIC CAPITAL CORPORATION, as administrative agent and second lien collateral agent (in such capacity, the “**Second Lien Collateral Agent**”) for the Lenders and the other Secured Parties (as each such term is defined in the Credit Agreement referred to below).

WITNESSETH:

WHEREAS, BBB Industries, LLC, a Delaware limited liability company (“Grantor”), and Second Lien Collateral Agent entered into (i) a Second Lien Credit Agreement, dated as of June 29, 2007 (the “Credit Agreement”), among Grantor, Second Lien Collateral Agent, the Lenders and the other parties thereto, (ii) a Second Lien Guaranty and Security Agreement, dated as of June 29, 2007 (“Guaranty and Security Agreement”), among Grantor, Second Lien Collateral Agent and the other parties thereto and (iii) a Second Lien Trademark Security Agreement, dated as of June 29, 2007 (the “TSA”), by Grantor in favor of Second Lien Collateral Agent pursuant to which, in the case of the Guaranty and Security Agreement and TSA, Grantor granted a security interest to Second Lien Collateral Agent in the trademarks, including the registrations and applications therefor, set forth on Schedule A hereto (the “Trademarks”) as security for certain obligations owing by Grantor to Second Lien Collateral Agent; and

WHEREAS, the TSA was recorded by the Trademark Division of the United States Patent and Trademark Office on (i) July 2, 2007, at Reel 003572, Frame 0898 and (ii) August 23, 2007, at Reel 003607, Frame 0678; and

WHEREAS, Grantor has requested that Second Lien Collateral Agent release its security interest in and to such Grantor’s Trademarks and the Trademark Collateral (as defined below) and reassign any and all rights of Second Lien Collateral Agent in and to the same to the Grantor.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Second Lien Collateral Agent hereby agrees as follows:

1. Second Lien Collateral Agent hereby releases its security interest in and to the Trademarks and all of Grantor’s right, title and interest in and to the following (collectively, the “Trademark Collateral”):

- (i) all licenses providing for the grant by or to Grantors of any right under any Trademark;
- (ii) all renewals and extensions of the foregoing;

(iii) all goodwill of the business connected with the use of, and symbolized by, each such Trademark; and

(iv) all income, royalties, proceeds and liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof.

2. Second Lien Collateral Agent hereby releases, relinquishes, terminates and discharges to and for the benefit of the Grantor, all of its security interest in and to the Trademarks and the Trademark Collateral, and reassigns, grants and conveys any and all of Second Lien Collateral Agent's right, title and interest in and to the Trademarks and the Trademark Collateral to Grantor that is the registered owner of such Trademarks.
